For what purposes do we process your personal data?

To which recipients will your personal data be assigned?

However, the personal data may be hosted at suppliers that could have their servers based in the United States of America (based on the agreement EU-US Privacy Shield) and in Chile, Singapore and Taiwan.

What rights do you have when you provide us your personal data?
